# Privacy Policy Report App website

Effective Date: September 1, 2019

This Privacy Policy applies to the Report App B.V. owned and operated website. Report App ("REPORT APP B.V.," "we," or "us") knows that you care how information about you is used and shared. This Privacy Policy explains what information of yours will be collected by REPORT APP B.V. when you access the Site (including through the websites of our partners), how the information will be used, and how you can control the collection, correction and/or deletion of information. We will not use or share your information with anyone except as described in this Privacy Policy. This Privacy Policy does not apply to information we collect by other means (including offline) or from other sources. Capitalized terms that are not defined in this Privacy Policy have the meaning given them in our Terms. The use of information collected through our Site shall be limited to the purposes under this Privacy Policy and our Terms of Service to customers.

## **Information We Collect.**
